The change in interests took place during the offer period, between 17 May 2021 to 28 June 2021, of the voluntary conditional cash offer (the "Offer") made by DBS Bank Ltd., for and on behalf of HHH Co Pte. Ltd. (the "Offeror"), to acquire all the issued and paid-up ordinary shares (the "SGH Shares") in the capital of Sin Ghee Huat Corporation Ltd. ("SGH") at the Offer price of S\$0.27 in cash for each SGH Share (the "Offer Price").

7,728,800 SGH Shares were validly tendered by Mr Low Ah Hoo ("LAH") in acceptance of the Offer in accordance with his irrevocable undertaking as disclosed in the Offer Document dated 17 May 2021 (the "Offer Document").

As at the date of the close of Offer, the Offeror received valid acceptances in respect of an aggregate of 166,003,410 SGH Shares under the Offer.
